

Frequently Asked Questions About The Girls Teams Moving To The East Central Soccer League

Q: What dates are play dates?

A: Playing weeks are the last week of April through the last week of June. The primary day of the play is when games will be scheduled for. The secondary date is for when games have conflicts and need to be rescheduled - reschedules happen more than a week in advance of the games.

Q: How many games will we play?

A: 1 game per week, 8 in total. The other date per week will be practice in Wausau.

Q: Where do we play?

A: 4 Home Games at Peoples, 4 Away Games in the Fox Valley which could be in Howard, Green Bay, Appleton, Oshkosh, Wi United Campuses.

Q: What time do we play?

A: Games will typically be played at 6pm (weekday games) with flexibility to change to later if teams agree.

Q: Where are practices?

A: Practices will still be in the Wausau area.

Q: How long can I get a refund?

A: Refunds are available through January 8 registration opening. Then, the club's no refund policy stands after January 8.

Q: If I'm unable to make a game, what happens?

A: We are able to work with you and your family to either carpool your player to the game or if your player misses a game, it won't be detrimental to the player or the team. Rosters are submitted on game days – we understand things come up.

Q: What happens if most of our team cannot make a game?

A: This league allows clubs to work with each other to reschedule games that don't fit team schedules. Alternative dates can be agreed upon and games can be rescheduled to fit team needs.

Q: Why ECSL?

A: The primary reason for this change is the lack of appropriate competition for our girls teams within CWSL. ECSL offers stronger overall competition, including tiered divisions that are age appropriate, which we believe will better support player development, challenge our athletes, and enhance their overall soccer experience. This allows our girls to play the correct competition and also have practice between games. The number of girls teams in the CWSL has dwindled so much that the coaches and club feel it no longer suits our girls teams. The girls program will pilot this move during the spring season to evaluate its long-term fit for the club.

Q: Who was involved in the decision?

A: The board had learned East Central was willing to have MC United in the league. After initial interest, all the girls coaches came together and had a meeting with Justin, the East Central Commissioner, and learned more about what it meant for the girls and MC United teams. After learning about the competition levels, flexibility in scheduling and rescheduling, flexibility in game day rosters and the overall league experience, the girls coaches were all in favor of the move to ECSL. Then, the board of MC United made the vote on the move of the girls to the ECSL..
